Candidates who have provisionally allotted seats are required to report IET Lucknow at 10:30 AM on 25/10/2021 for document verification and seat confirmation (by depositing **Rs. 50000/- (preferably DD)** as seat confirmation fees after successful document verification). Candidates have to **confirm the seat before 3:00 PM on 25/10/2021**. In case of failure to confirmation the seat, seat allotment will automatically be cancelled and allotted seat would be considered as vacant seat for next allotment/upgradation.

2. **Wait listed candidates** are required to report IET Lucknow **at 02:00 PM on 25/10/2021** for document verification. If seats remain vacant candidates will be allotted seats on 25/10/2021 and candidate has to confirm seat on same day i.e. **on 25/10/2021 by 4:30 PM**. Candidates are suppose to come with all relevant documents and seat confirmation **fees Rs. 50000/- (preferably DD)**.

Candidates Must note down:

1. **OBC–NCL certificate** issued from Govt. of U.P. **on or after 01/04/2021** only will be considered to be valid for admission. (Applicable for OBC-NCL candidate)
2. **OBC–NCL certificate issued for specific purpose (like for the post of Central Govt.) will not be considered valid** for admission purpose. (Applicable for OBC-NCL candidate)
3. **EWS certificate** issued from Govt. of U.P. **for year 2021-22 or issued on or after 01/04/2021** will be considered to be valid for admission. (Applicable for EWS candidate)
4. For admission under GATE qualified category, **candidate must have qualified in his/her respective category** (Gen/ OBC/SC etc.) with a valid score card.
5. The Candidates who will be provisionally allotted seat must report at the institute, with all the relevant original valid documents (category certificate, domicile certificate, Qualifying exam mark sheet/certified internet copy of mark sheet, High school certificate etc.) at the time of document verification and seat confirmation, failing which his/her allotment under respective category shall stand cancelled.
6. Candidate must also bring two photographs and one set of self-attested copy of relevant documents for verification at the time of reporting, along with confirmation fees (preferably DD in favour of **Director, IET Lucknow payable at Lucknow**). If the candidate is finally allotted seat after document verification, he/she **has to confirm the seat on the same day by depositing fees (Rs 50,000/-) for seat confirmation.**
7. **Counselling fee receipt (Rs. 500/-)** must be brought at the time of physical reporting.
