1. Interested and eligible candidates are requested to fill the prescribed *Online Application Form* available on the Institute Website <http://www.ietlucknow.ac.in> and uploaded the scanned copy of DD for payment of the required application fee.
2. Only those applications, who have uploaded the scanned copy of DD for payment of required application fee shall be considered valid. Incomplete applications or applications without scanned copy of DD shall be summarily rejected and no communication in this regard shall be entertained.
3. The schedule of Test/Interview shall be notified on the Institute Website <http://www.ietlucknow.ac.in>. The candidates are required to keep on visiting the Institute Website regularly and report for Test/Interview in the Institute accordingly. No separate intimation, written or verbal, will be sent to the applicants.
4. The applicants, on the scheduled date(s) of Written test/Interview must bring the three set of printed hard copy of the filled **Online Application Form** along with their original certificates testimonials and original DD.
5. Candidates are also required to bring Self attested Photo copies of relevant degree & experience certificate, passport size photograph along with proof of identification at the time of Interview, failing which they shall not be allowed to appear in Interview.
6. Applicants must fully satisfy themselves about their eligibility as prescribed by AICTE, before appearing in the Interview. If an applicant is inadvertently allowed to appear in the Interview who otherwise does not fulfill the minimum eligibility requirements, he/she cannot, at a later date, use that as right to claim that he/she meets the eligibility requirements.
